This residence was approved as an Assisted Living. That use has now ended. Looking for ideas on what can be done with the home. Possible uses discussed, boarding house and dormitory for Andrews University students or faculty members, and Bed & Breakfast. Possible Ordinance amendment or a conditional zoning agreement, or possible home occupation. A public hearing would need to be held and the council would need to approve. This is just an early discussion. This home has always been a “building of service” and Ms. Bodley would like it to remain that.

The term limits, resignations, reappointments are just some of the processes that needs to be cleaned up.


