- Call to Order: DDA Meeting was called to order at 6:30 p.m. by Chairman Demski.
 Planning Commission meeting was called to order at 6:30 p.m. by Chairman Knoll.
- 2. Introductions and Purpose of Meeting: DDA Chair Demski summarized the purpose of the joint meeting being an invitation from the DDA to the Planning Commission to discuss several items of mutual interest and to explore methods to work together addressing them.
- 3. DDA Sidewalk Use Permit Application: An application submission from owner/operator of the Home Town Deli property was presented.

DDA Members Martin, supported by DDA member Rudlaff moved, to approve "the 2014 application consisting of 2-tables & chairs" Motion carried unanimously.

4. DDA & PC - Request by Round Barn Brewery for Minor PUD Amendment: Chris Moersch presented a request to reshape and extend the outdoor seating area roofline and to install garage doors for weather protection. Responding to inquire, he noted, the Champaign Tank sign identifier will be installed this sparing due to delay in preparation of same for installation before inclement weather.

DDA Member Nye, supported by DDA member Rudlaff, moved to "approve the Minor PUD Amendment per drawing dated 01.15.14 prepared by Heidi Hornaday, Architects, Inc." Motion carried unanimously.

Planning Commission Member Rath, supported by Planning Commission member, Zordell, recommending Village Council "approval of the Minor PUD Amendment per drawing dated 01.15.14 prepared by Heidi Hornaday, Architects, Inc." Motion carried unanimously.

- 5. DDA Consideration of Expansion of Commercial Zoning: DDA Chair Demski opened discussion summarizing the request made by DDA Member Nye for the DDA to request a meeting with the Planning Commission to discuss extending the commercial zoning classification to select areas on Second Street and possibly other areas. Discussions ensued about areas that could be considered with the Planning Commission expressing willingness to consider suggestions. Planning Commission Chair Knoll suggested the DDA prepare a specific proposal for consideration by the Planning Commission. Upon receipt a special DDA & Planning Commission joint committee would gather all comments and prepare a specific proposal for possible Planning Commission action.
- 6. **DDA Discussion of Community Projects and Priorities**: DDA Chair Demski opened discussion summarizing DDA discussions regarding the priority of the Church Street, Menser Drive, South First Streetscape and Water tower/Second Street parking lot projects. Discussions ensued concerning priorities, Village financial resources and state funding opportunities. No conclusions or priorities were reached. All parties discussed importance of having jobs and investment commitment to strengthen request for state financial assistance, and priority will likely be given to the project that can secure financial assistance. Recognition was given to fact that a Church Street "fix" will be needed this year.

- 9. Other Report and Items of Interest: DDA member Hurst discussed the desire to conduct a communitywide survey as was completed by the Planning Commission in 2002. Planning Commission members were receptive to this idea and suggested the DDA prepare a sample survey for their review and consideration.
