- D. Time Clock –Deputy Clerk Tomlinson presented information on a new time clock for the Village. Deputy Clerk Tomlinson stated that she, Clerk/Treasurer Martin, and President Getz took part in a webinar to learn more about the system. Deputy Clerk Tomlinson shared that the time clock would communicate with our current BS & A software, allow all employees to clock in and out remotely, within a range, using a cell phone, lap top, etc., keep track of time off requests, would be more accurate, and would eliminate issues that are currently causing payroll to take hours to calculate. A motion was made by Trustee Turney, seconded by Trustee Nye, to purchase the time clock. All ayes, motion carried.

Clerk Martin will contact Road Commission to see if the Village can get on the schedule to do markings after the Village road projects are complete.
